Mr. William E. Aydelott '68 – President/Founder, Waverly Motion Pictures, LLC

Bill Aydelott loves movies and television, but has radio in his blood. He grew up in Waverly, Pa, and was making student films even , ultimately graduating from Dartmouth as the college's first special major in film theory and production. He often supported his "film habit," by holding down regular on-air shifts at several Northern New England radio stations. Founding Aydelott Associates in 1974, he undertook everything from ski films for Chevrolet Sports to corporate profiles for Bendix and Polaroid, as well as documentaries for the National Fire Protection Association, emotional fund-raising appeals for The United Way, and PSAs for the Special Olympics. In the 1980s, he began combining his longtime radio experience with a growing knowledge of

film production techniques, and launched a hugely popular and successful series of ads promoting WBZ Radio's Dave Maynard. Known as "The Piece a' Cake!" campaign, they involved elaborate stunts and memorable humorous moments, winning not only high ratings for the station, but a number of national advertising awards. Many of these were subsequently adapted for similar stations and personalities in other markets, and in the intervening years, he has established himself as one of the proven experts in creating original television promotions for radio. He also produced and operated camera on the first full-length feature movie by writer/director John Sayles, "The Return of The Secaucus Seven" – a film that went on to make the 1980 Ten Best list of a variety of national reviewers.

Following a three-year stint as senior vice president at Filmhouse in Nashville, Tenn., Mr. Aydelott returned to Boston to establish Waverly Motion Pictures and continue his work both with the major Hollywood studios and with many of the most prominent radio stations in America. Himself an experienced cinematographer, Mr. Aydelott is still best known for his abilities in directing talent and "real people," and is often solicited by other production companies to assist on projects involving that expertise. This includes producing and/or directing promos and longer format shows for The Discovery Channel, HGTV, and PBS. He has appeared on Good Morning America and won multiple Best Director honors from the New England Emmys and the New England Broadcasting Assoc. In addition, Aydelott Productions has taken several first place Golds at both the International Film & TV Festivals of New York and the U.S. Television Commercials Festival.



Mr. Bradley L. Baldia '91 – CEO & President, Upward Synergy

In 1995, Brad served as a White House Intern in the Office of Presidential Personnel. He currently works as the CEO & President of Upward Synergy. Brad works extensively with Asian community organizations on a local and national level, such as the Pan Asian Association of Greater Philadelphia and the National Association of Asian American Professionals (Brad is Past-President of the Philadelphia Chapter and was elected in August, 2006 as Executive Vice President of NAAAP National and National President & Chairman in August, 2008).

He serves on various boards including the Multicultural Affairs Congress (Philadelphia Convention & Visitors Bureau), Power Shift, National Federation of Filipino American Associations (NaFFAA) PA. Brad is also a member of the PA Attorney General's AAPI Advisory Committee, the FBI Philadelphia's Multi-Cultural Advisory Committee and serves as faculty for the Center for Progressive Leadership in PA. Brad was appointed as one of twenty-five individuals to the Philadelphia Mayor's Commission on Asian American Affairs. Most recently, Brad was appointed to the board of the Library of Congress Asian Division Friends Society and a DOJ Arab/Muslim/Sikh/Asian Working Group.

Mr. Baldia has received numerous awards for his efforts, including the "Unsung Heroes Award" by Keystone Mercy Health Plan and "National Brotherhood/Sisterhood Award" by the National Conference on Community and Justice. In 2002, he was recognized as one of the "Top 30 Most Influential Asians in America Under the Age of 30". In 2007, Brad was one of fifty individuals citywide that was nominated for the "Spirit of Philadelphia" award by Greater Philadelphia Cares. In July 2008, Mr. Baldia was named one of Philadelphia's 101 Top Connectors by LEADERSHIP Philadelphia. Brad received his BA in English and Biology from Bucknell University and a Masters in Public Health from Temple University.



Mr. Christian M. Baldia '86 – President, Constellation Strategy & Analytical Services

Christian Baldia is the President of Constellation Strategy & Analytical Services, a cutting-edge management consulting firm that assists organizations with critical issues such as the post merger integration of companies, the breakdown of barriers between departmental silos and the development of innovation networks throughout a firm.

Previously, he served as a Managing Director at Virtcom Consulting, a management consulting firm serving major corporations, NGOs and government agencies around the globe. At Virtcom, he specialized in organizational connectivity (social network analysis), collaboration, employee engagement, and global diversity & inclusion issues.

During the 2004 U.S. Presidential election, Mr. Baldia worked for Americans Overseas for Kerry. He served first as a Senior Advisor and Speechwriter at the AOK Spain office in Madrid, and later as the Communications Director for AOK's global operations.

Prior to the Kerry Campaign, Christian Baldia served at the Federal Reserve Bank of New York as a Senior Financial/Economic Analyst in the Policy and Analysis division of the Bank Supervision Group. Immediately prior to that, he worked as an investment banker at Butler, Chapman & Co. and PaineWebber Incorporated (now UBS PaineWebber).

Mr. Baldia previously served for four years in the Clinton Administration as a Senior Policy Analyst at the U.S. Department of the Treasury and as a staff member for the White House in the Office of Presidential Personnel. Prior to those positions, he had worked as a volunteer for the Clinton-Gore Presidential campaign and for the Presidential transition team.

He is a graduate of the University of Pittsburgh's University Honors College, Cum Laude, (B.Phil., Politics & Philosophy/History and Philosophy of Science) and earned a masters degree from Harvard University's John F. Kennedy School of Government.



Mr. William N. Barnshaw III '95 - Chief Operating Officer, MRS Associates

Bill Barnshaw is chief operating officer of MRS Associates, a nationally licensed, full-service accounts receivable management company that specializes in accounts receivable management, customer relationship management, and back office management. Mr. Barnshaw is responsible for managing all aspects of MRS's collection divisions and its three call centers in New Jersey, Ohio, and Mumbai, India. While ensuring that client expectations are being met and exceeded, his focus is on the increased use of analytics, devising new strategies to drive better performance, identifying cost-saving opportunities, and spearheading the company's continued operational expansion both domestically and internationally.

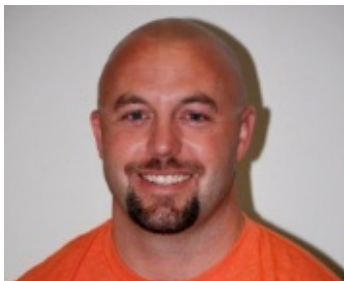

Mr. Aleco Bravo-Greenberg '86 – Creator/Executive Producer of *Hurricane Hunters*, The Weather Channel

Aleco Bravo-Greenberg is a lawyer, real estate investor, and television producer. He is the creator and executive producer of *Hurricane Hunters* for The Weather Channel. “Hurricane Hunters” tracks a team of members of the Air Force Reserve Squadron who take meteorology to the extreme level of flying into the eye of hurricanes in an attempt to better understand them. Originally from Mexico City, Mr. Bravo-Greenberg grew up in Washington, D.C., and currently splits the coasts,

between Los Angeles and Washington, D.C. Aleco serves as a Board Member of the DC Police Foundation and as a volunteer member of the Washington, DC Metropolitan Police Department. Also a horseman and a bullfighter, he's made cameos in media ranging from, *USA Today*, to ESPN, to soap operas. While at The Hill, Mr. Bravo-Greenberg was a varsity track captain and Penn Relay gold medalist. He received a B.A. from the University of Virginia and a J.D./M.B.A. from Georgetown University.



Capt. James A. Brobyn '96 – Executive Director, Travis Manion Foundation/ U.S. Marine, Veteran of the Iraq War

James Brobyn is currently the executive director of the Travis Manion Foundation, a national nonprofit organization advocating for and supporting our nation's veterans and their families. From 1997 until 2010, Capt. Brobyn served in the U.S. Marine Corp as an infantryman in the Iraq War, where he earned a Purple Heart for his service. Capt. Brobyn is a 2004 graduate of the U.S. Naval Academy, where he served (and continues to serve) as vice president of his class and earned a degree in political science.

Capt. Brobyn was an enlisted Marine for several years prior to his admission to the U.S. Naval Academy and his commission as a Second Lieutenant. He subsequently served two combat deployments in Western Al-Anbar Province, Iraq as an infantryman with Third Light Armored Reconnaissance Battalion – first as a platoon commander and then as the Executive Officer of Apache Company. He received a Purple Heart after he was wounded in an IED attack during his first deployment.

Following his tour with the Wolfpack, Capt. Brobyn transitioned to Marine Corps Recruit Depot San Diego, where he first served as a series commander; later, he was personally selected by the Commanding General to serve as the Depot Protocol Officer. Capt. Brobyn transitioned out of the Marine Corps and began work with the Travis Manion Foundation in the beginning of 2011. His responsibilities include: managing operations, the integration and execution of all Foundation directed programs and events, strategic planning and partnerships, compliance, information technology, social media, and branding of the Foundation. In 2012, Capt. Brobyn earned his M.S. in nonprofit/NGO Leadership from the University of Pennsylvania, and was the recipient of the Richard Estes Global Citizenship Award.



Ms. Olivia P. Cap '08 – Aquarist, Audubon Aquarium of the Americas

Olivia Cap is an aquarist for the Audubon Aquarium of the Americas in New Orleans, La. In her role, she is responsible for the care and maintenance of the Aquarium's Caribbean Gallery which houses many different species of Caribbean reef fish and invertebrates. Ms. Cap studied environmental science and policy at Smith College in Northampton, Mass.

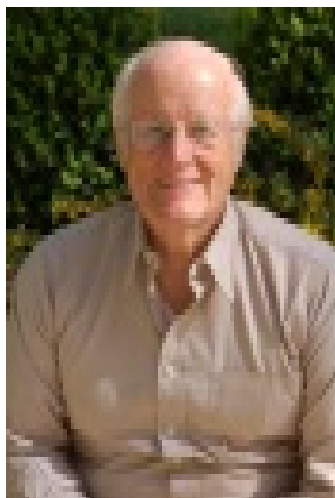
Mrs. Laura Crandon P'15 – Vice President, Business Development & Strategic Alliances, UnitedHealth Group Alliances

Mr. William H. Devaney III '84 - Attorney/ Partner, Venable LLP

William (Widge) Devaney is co-chair of Venable's Foreign Corrupt Practices Act (FCPA) and Anti-Corruption Group. Mr. Devaney's practice includes white-collar criminal defense in federal and state proceedings, SEC enforcement investigations and actions, complex civil litigation, civil RICO, defending individuals and corporations in multi-national investigations, including FCPA and export control, as well as conducting national and international internal investigations on behalf of corporate management, audit committees and special committees of boards of directors. Mr. Devaney was an Assistant United States Attorney in the District of New Jersey, where he was most recently a member of the Securities Fraud Unit. As a federal prosecutor, Mr. Devaney investigated and prosecuted numerous cases involving securities fraud,

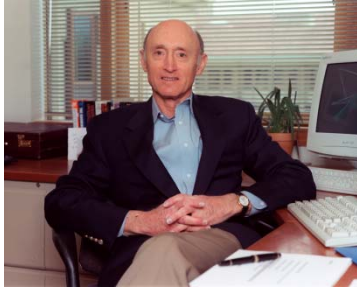
Mr. Joseph G. Fawkner '96 – Senior Director, International Development, U.S. Chamber of Commerce

He also served as the Head of Congressional Affairs at U.S. Asia Institute, and has 15-plus experience in U.S. and China business development. He earned his B.A. from Boston College, and completed graduate studies at the University of Oxford.



Mr. David N. Greenlee '61 – U.S. Ambassador, United States Government

David Greenlee began his military service in 1968, serving in Vietnam until 1971 as a first lieutenant, earning him a Bronze Star with Oak Leaf Cluster. Mr. Greenlee then served in the U.S. Peace Corp in Bolivia from 1965 to 1967, followed by work in the Foreign Service in 1974. Mr. Greenlee served as Rotational Officer at the U.S. Embassy in Lima, Peru; Watch Officer in the State Department Operations Center; Political Officer at the U.S. Embassy in La Paz, Bolivia; Political Officer at the U.S. Embassy in Tel Aviv, Israel; International Relations Officer in the Office of Israel and Arab-Israeli Affairs; Deputy Director in the Office of Egyptian Affairs; and as a student at the National War College. Mr. Greenlee was nominated by President George W. Bush to serve as the U.S. Ambassador to the Republic of Bolivia in 2002. Prior to that appointment, Ambassador Greenlee served as U.S. Ambassador to the Republic of Paraguay from 2000-2002; he was a Special Coordinator for Haiti at the Department of State from 1997 to 1999; U.S. Delegate (Ambassador rank) and Chair of the Israel-Lebanon Monitoring Group from 1996-97; Political Advisor to the Army Chief of Staff from 1995-96; and Deputy Chief of Mission at the U.S. Embassies in Madrid, Spain (1992-95), Santiago, Chile (1989-92), and La Paz, Bolivia (1987-89). Mr. Greenlee received his B.A. from Yale University.



**Dr. Charles A. Holloway GP'14 – Kleiner Perkins Caufield & Byers
Professor of Management, Emeritus; Director of the Center for
Entrepreneurial Studies at Stanford University**

Charles Holloway holds Stanford University's Kleiner, Perkins, Caufield & Byers Professorship in Management Emeritus. Dr. Holloway has become a leader in the study and teaching of entrepreneurship, supply networks, and technology management. He has recently developed two new courses in this area, Evaluating Entrepreneurial Opportunities and Strategy and Management in Supply Networks. He also teaches courses on the formation of new ventures. He is one of the directors of the Stanford Center for Entrepreneurial Studies at the Graduate School of Business aimed at curriculum development and research on smaller, rapidly growing companies. He was the founding co-chair of the Stanford Integrated Manufacturing Association, a cooperative effort between the Graduate School of Business and the School of Engineering, which focuses on research and curriculum development in technology and manufacturing, and helped develop a joint program to prepare doctoral students in this area.

Dr. Holloway has a B.S. in electrical engineering from the University of California, Berkeley; an M.S. in nuclear engineering; and Ph.D. in business administration from the University of California, Los Angeles. He joined the faculty of the Stanford Graduate School of Business in 1968, where he has served in a variety of positions at the GSB, including Associate Dean for Academic Affairs, from 1980-87 and 1990-91, as well as in the University, most recently as chair of the University Commission on Graduate Education. Prior to coming to Stanford, Dr. Holloway served as assistant to the Technical Director at Naval Reactors, a joint organization of the Atomic Energy Commission and the Bureau of Ships, where he worked closely with Admiral H.G. Rickover on the development of nuclear powered-ships. He also worked as a senior engineer for Bechtel Corporation's Scientific Development Department.

Dr. Holloway has served as a board member for more than 10 start-up companies in a range of industries. He is currently on the board of SRI International as well as several smaller companies. He is the author of *Decision-Making Under Uncertainty: Models and Choices*, co-editor of *The Perpetual Enterprise Machine--Seven Keys to Corporate Renewal Through Successful Product and Process Development*, and many articles in the field of management.



Mr. Jason W. Ingle '93 – Founder & President, Greener Partners

Jason Ingle is the Co-Founder and President of Greener Partners, a non-profit organization working to compel potential partner organizations to take underutilized land holdings and put them into sustainable agriculture for the benefit of surrounding communities. Since 2007, Greener Partners has grown to more than 40 farmers, educators, and other staff managing over 110 acres of certified organic community farms and hosting more than 8,000 school students annually to learn about the food system.

Prior to co-founding Greener Partners, Mr. Ingle spent much of his career in the finance industry. With Fairlane Partners, he invested or co-invested capital at an equity level in early and growth stage ventures within the Northeast and Mid-Atlantic region. Prior to Fairlane, Jason, along with his partners, managed Aslan Capital, a credit opportunities fund based in Manhattan that focused on corporate turnarounds and reorganizations. In January 2013, Mr. Ingle was appointed to The Hill's Board of Trustees. He also serves on the nonprofit boards of Spring Garden Pictures, a social causes non-profit film production organization based in Philadelphia; Tyler Arboretum, a 650-acre arboretum west of Philadelphia; and the Investment Committee for the Elwyn Institute, which is one of the nation's oldest non-profit organizations serving people with developmental and behavioral challenges. Mr. Ingle received his B.A. from Boston University. He and his family live near Philadelphia, Pa., but also split time in Maine, New York, and Vermont.



Ms. Marina Kats P'16 – Owner/President, Kats, van der Veen & Associates

Marina Kats is the founder of the law firm Kats, van der Veen & Associates: Today, the firm is a well-respected litigation firm with offices in Pennsylvania, New Jersey, and New York. The firm concentrates its practice in representing individuals and businesses in all areas of civil and criminal litigation. The firm was successful in representing clients before the Pennsylvania Supreme Court; has secured several pardons for its criminal clients from the Governor of Pennsylvania; and recently obtained a number of multi-million dollar verdicts in front of Federal and State juries. Aside from her pursuits in law, Ms. Kats is a successful businesswoman. She is the general managing partner of a number of real estate ventures and commercial projects. Ms. Kats also is the principal owner of a financial services company that provides funding and financial services for independent businesses and joint ventures. She was the president of a popular AM radio station and co-hosts a weekly radio show on New World radio. Ms. Kats also co-produced and co-hosted a weekly television show called "What Do You Think?" with the Honorable James DeLeon from the Municipal Court. For her many successes in business and law, Ms. Kats was elected "One of the 50 Best Business Women in the Commonwealth of Pennsylvania" by the Governor in 1997. Ms. Kats also was honored as "Woman of the Year" by the Bucks County YMCA and as "Consumer Advocate of the Year" for the past three consecutive years. Ms. Kats also is actively involved with a number of charitable and civic organizations: she is a board member of the Hias Organization; a member of the American Diabetes Association; and a member of the Temple Law Alumni and charter member of the law school's centennial. Additionally, she was actively involved in the Philadelphia Committee to End Homelessness. Currently, Ms. Kats is president of the Russian-American Chamber of Commerce and she conducts regular lectures to its members on legal and civic issues. Ms. Kats is a graduate of Temple University. A resident of Meadowbrook, Pa., she is the mother of current student, Alexandra Kats.



Mr. Frederick C. Lee '68 – CEO, Healthrageous

Frederick Lee is the founder of Healthrageous, a health care firm which helps people change lifestyle behaviors that ultimately lead to chronic disease. The firm contracts with health plans and pharmaceutical companies. Mr. Lee has made a career in the creation and sales of specialty health care applications sold to employers and health plans. He has been on the founding team of four health care start-ups including Healthrageous. Previous to founding Healthrageous, Mr. Lee was director of GTESS Corporation, president of Employer Solutions at Magellan Health Services, senior vice president of Health Plans at Matria Healthcare, and founder of Quality Oncology, Inc. He is a recognized expert in the field of cancer disease management and has been published in several healthcare journals. Mr. Lee is a graduate of Harvard College and the University of Washington School of Public Health.



Mr. Noah Levine '05 – Executive Director (Global), SEEDS Foundation

Noah Levine is the executive director of SEEDS (Sports for Education and Economic Development in Senegal), a non-profit organization that uses basketball as a hook to engage promising Senegalese and African youth in educational programming. Mr. Levine joined SEEDS in 2012 and is responsible for overseeing the day-to-day operations and management of the organization. SEEDS serves approximately 500 African youth annually through academic programming, basketball training, leadership development, and English language enhancement. Prior to SEEDS, Mr. Levine was an associate for Foxrock Partners, a sports and entertainment marketing agency in N.Y. Mr. Levine has also served as development associate for New Heights Youth, a youth education sports non-profit that serves underserved youth throughout the NYC area. Levine serves on the Junior Board for New Heights Youth. He received his B.A. from Princeton University. He currently lives in New York City and travels to Africa throughout the year.



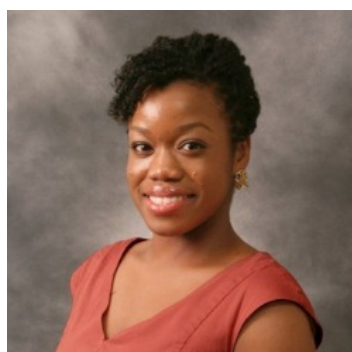
Mr. Evan M. Litvin '04 – Architect, Bohlin Cywinski Jackson

Evan Litvin secured a position as an architect with the Philadelphia firm Bohlin Cywinski Jackson after recently earning a M.Arch from the University of Pennsylvania. Mr. Litvin is also actively involved in the effort to repurpose Philadelphia's many closing schools. While a student at U.Penn, Mr. Litvin was part of a winning team of an on-campus competition to develop practical public policy plans for the city.
